V. Financials

a) 1st Quarter Financials

Late and NSF fees are consistently budgeted low hoping members renew on time.

b) Auditor Review – Jeff Eckstein, MNP

2022 Audit Findings

Clean audit report. No matters brought forth by directors or management. No changes in accounting policies. Policies have been consistently applied. No significant deficiencies in internal controls. Standard adjustments were made as in previous years.

2022-2023 Audited Financial Statements
 Balance Sheet: Standard clean audit opinion. 2% decrease in assets 2023 vs. 2022.

Internally restricted investment balance decreased. Prepaid expenses includes Thentia database contract. Capital asset additions include office furniture, IT hardware. Deferred contributions – annual membership fees.

Statement of Revenues and Expenses:

Rise in interest rates in 2023 vs. 2022. Reviewed increases in expenses including salary and benefits line increase of 7%. Unrealized loss on investments – publicly traded investments within the portfolio are required to be adjusted to market value at March 31. Markets have been volatile as of late – not an actual realized loss.

Statement of Changes in Net Assets:

100% of investments are internally restricted.

Motion not required to record investments as internally restricted as investment activity is automatically internally restricted. Only withdrawals will require a motion.

Statement of Cash Flow:

Continuity of cash balance at beginning of year to end of year including investment activities which includes capital and intangible assets.

Notes to Financial Statements:

Consistent year over year. Disclosing all significant accounting policies.

Nil funds were transferred from the unrestricted fund to the internally restricted fund to meet reserve targets.

c) In-Camera Session – Board Member Questions for Auditor

Be it resolved that the Board will enter in-camera session with auditor to confirm results of audit. CARRIED.

Board requests review of investment policy, overview of funds the College is investing in and a discussion about the of the frequency of such reviews at the Finance Committee.

Barb and the Treasurer meet annually with the investment company. Will request the Finance Committee join in on the next review. The investment policy is specific about types of funds MCSW is investing in – pulling in code of ethics.

Be it resolved that the audit report for the period of April 1, 2022 to March 31, 2023 is approved as presented. CARRIED.

d) Appointment of Auditor

Be it resolved that MNP shall be recommended as auditor for the April 1, 2023 - March 31, 2024 fiscal year at the 2023 Annual General Meeting. CARRIED.

National Day for Truth and Reconciliation – TRC resources hub updated on website, land acknowledgement working group seeking new members, Barb attended the Reconciliation Run in Birtle, MB.

Seven Oaks School Social Workers – Barb met with Superintendent, Assistant Superintendent of Seven Oaks to educate on the important role of social workers in schools.

Issued open letter to political parties promoting regulation – no response to date.

Increase in both registration and complaints appeals. Thank you to Board members for participating in the appeals.

Barb attended the Registrars' Meeting in Saskatchewan – topics included labour mobility and registration practices, fees, workforce issues, cautions and counsels, cross-jurisdictional complaints.

CASW Code of Ethics revision is complete – a series of webinars will be offered. The Code of Ethics will be introduced formally in January. Once the Code is determined, a future project is looking at the Standards of Practice.

MCSW staff attended the Canadian Network of Agencies for Regulation (CNAR) Conference in Vancouver. MCSW is a new member and looking to connect with Canadian regulators.

Barb and Jen are attending the ASWB Delegate Assembly in November. Barb is part of the Regulation and Standards Committee and brings the Canadian perspective.

VIII. New Business

a) Glenn Drover National Award for Outstanding Service

The Board can put forward a name as a partner organization.

b) Scholarship Policy Revisions

New requirement that member must be registered for 2 years before applying.

Be it resolved that the revisions to the Scholarship Policy are approved as presented. CARRIED.

c) CCP Compliance Resolution Policy revisions

Change is due to members who did not finish CCP requirements at renewal – reviews can be initiated at any time not just at renewal.

Be it resolved that the revisions to the CCP Compliance Resolution Policy are approved as presented. CARRIED.

d) Topics and Trends in Social Work

Manitoba Housing does not have accessible housing in their portfolio. To be discussed at next meeting along with guideline.

e) Legislation and By-Law Committee

Legislation currently states title Social Worker is limited to those in the Practicing category only. Retired members cannot say they are a retired social worker. Ontario created a retired social worker category. The public needs to understand if a member is eligible to practice. Barb will gather data to see what other jurisdictions have done will bring it to future meeting.

Barb will bring new Terms of Reference for this committee to next meeting.

IX. ASWB Exam Analysis Discussion and Presentation

- ASWB Exam Analysis Summary
 Questions were sent to ASWB in advance. The questions are not exhaustive, questions may still
 arise.
- ASWB Presentation Stacey Hardy-Chandler, CEO ASWB
 Reviewed structure of ASWB elected board of directors. 11 directors and 3 are Canadian. 64 regulatory state boards and provincial colleges. 72 appointments made, 18 were Canadians, 3 were indigenous.
 - Practice analysis completed in 2017: of 32,077 responses, 9520 registered in Canada.
 Statistical comparisons indicated minimal differences in ratings between Canada and US.
 - Exams developed by 20 ASWB staff out of 49 staff total.
 - Does ASWB employ Canadians? Prior to the pandemic, 100% of staff are residents of Virginia. Post-pandemic with hybrid work options, more are employed outside of Virginia
 - Item development consultants are paid by ASWB as contractors with demonstrated exam expertise in social work
 - 65 volunteers, 90 item writers (people who are social workers developing questions.)
 ASWB staff do not write exam questions. ASWB exam committees each have one Canadian member.
 - Item writers are listed in a yearbook on ASWB website. Diverse group of item writers representing a wide variety in the profession, including Canadian item writers.
 - 4 different types of exams all with the same structure. 170 questions, 150 scored with 20 pre-tested. 4 option multiple choice with 3 option questions launched in January 2023 with the same 4 hour time limit.
 - Universal pass score no matter where you take the exam
 - Items are randomly administered questions numbers will be different for each exam taker.
 - Multiple forms of exam are rotated quarterly.
 - Computer-delivered at centers across the US and Canada. Accommodations can be made a test-site.
 - 2024 new vendor administering exam PSI. Exploring remotely proctored exams.
 - Exams estimated to be at 10th grade reading level. Item writers receive training in best practices. 7 Item Development Consultants reviews items written by Item Writers. If item accepted, it goes to ASWB Examination Committee followed by pre-testing. When something is accepted it does not go on scored portion of the test. It is monitored as a pre-testing item to start. If good statistics and consistent across self-reported demographics it will be added as a scored item. If poor statistics it is flagged and deleted.
 - Outcome disparities do not start in the exam room. They start in schools.
 - Social Work Workforce Coalition Thunderbird Circle no longer a part of coalition.
 - Social Work Census next one takes place next year. Practice Analysis Task Force will be leading the next Census. Of 33 members, 6 are Canadian and 4 identify as Indigenous.
 - Plan to understand social workers and their affiliates
 - Next exam blueprint will be developed from the data

- Full suite of resources geared towards educators online.
- Webinar series offered in December 2022, February 2023 and June 2023 discussing the exam.
- Test mastery mindset support if someone does not pass the test they are offered to take a program.
- 2022 report published on pass rate analysis:
 - Board voted to compile reports and publish data through a report, interactive map of pass rates, and social work schools and programs reports.
 - Manitoba data: Bachelors exam first time pass rate 90.9%
- What we can do: encourage social workers to participate in ASWB initiatives; encourage members to complete census; go to the source for information; support future research to provide context to the 2022 descriptive data.

Q: What are the risks/challenges to having an International versus a national exam? Would there be value in developing a specific exam for Canadian exam writers?

- Exam is international. A Canadian specific exam is being looked at particularly in French. More to it than translation of words. Will happen from practice analysis in March of 2024.

Q: Does ASWB have or would they consider a Canadian chapter of ASWB or a Canadian sub-committee to ensure that the exam and ASWB policies and procedures are relevant to Canadians?

 Operational serving larger organization of members. Would have to be an emerging request from members, voted on at delegate assembly.

Q: Why have pass rates remained consistent for Caucasian exam writers and inconsistent for those who are Indigenous? Why is the rate of Indigenous test takers at a low 1%?

- ASWB requires additional research into this question. They don't know what brings people to the test experience. ASWB wants to know the answer and is investing in the research.

Q: How is the exam writer compensated by ASWB? Costs to College?

- Exam writers are compensated by ASWB.
- Costs to College include ASWB membership fees. Candidates pay ASWB directly to write the exam.
- Some schools pay for their students to write exam.

Q: Do you need to consider accessibility laws in Canada:

- Yes, they consider all accessibility laws by jurisdiction.

Q: In moving from Pearson Vue to PSI, Manitoba does not have a PSI site. We currently use exam for Booth grads and Substantial Equivalency. How will this be resolved?

- PSI has to ensure that they have at least one test site in each jurisdiction. There is one planned for Winnipeg. Mobile sites are also a possibility. Plan to offer secure remote proctoring for accessibility next year 2024.
